The goods/materials can be inspected by the prospective renderers or their authorized representatives in the premises of the Gallery during the office hours from 10.01.2019 to 11.01.2019.

Tender will be opened at 14.00 Hrs. On 15.01.2019 in the presences of such of the tenders or theirs authorized representatives who may wish to attend.

General Condition:

1. Sealed tenders superscripted "Tender for Unserviceable Items addressed to the Drawing and Disbursing officer, National Gallery of Modern Art, Jaipur House, Near India Gate, New Delhi so as to reach him on before 15.01.2019 at 1.30 pm.
2. A sum of Rs. 10,000/- (Rupees Ten Thousand) is required to be deposited as Earnest Money along with the tenders in the form of Grossed bankers Cheque/ Pay order/ bank Draft drawn in favour of the Administration Officer, N.G.M.A New Delhi. Filling which the quotations will be summarily rejected Cheque, cash or postal order will not to accepted in any case.
3. Material should be removed on; as is whereas; basis within 02 days from the receipt of acceptance order after depositing the full amount (after adjusting Earnest Money of Rs.10, 000/- (Rupees Ten Thousand Only) with the cashier of the Gallery in the form of Crossed Bank Draft/ Pay Order/ Banker Cheque drawn in favour of the Pay & Accounts Officers, Department of Culture, New Delhi. In case material is not removed within the prescribed time the Earnest Money will be forfeited and any loss whatsoever occurring due to this will be recovered from the bidder.
4. The inspection of material should be done carefully and queries based to the concern officers at time of inspection no. further clarifications shall be given after the above inspection.
5. No damage should be caused to the existing property of the Gallery of Government while removing the auctioned articles from the site. Any law/damage to the Government/Gallery of injury or personal accident suffered by any person due to the negligence or the action of the successful bidder or his authorised worker/ Supervisor will have to indemnified by the successful contractor.
6. Goods/Martial to be removed will be under the supervisor of designated officer of the Gallery.
7. Goods/Martial will be allowed to be removed only during working hours. The articles will not be allowed to be removed on holidays or after working hours.
