The post is required to be filled up by Composite Method (Deputation (including short-term contract) plus promotion). The candidate selected is to be posted in the branch of NGMA, Bengaluru.

2. Job Description

The National Gallery of Modern Art (NGMA), a premier museum of India with a rich and exquisite collection of contemporary paintings, under the Ministry of Culture is seeking qualified candidates for the post of Assistant Director (Administration & Finance) at NGMA, Bengaluru. The incumbent will be responsible for all matters relating to administration, finance and vigilance, preparation of annual budget, allocation of funds to field units, monitoring and controlling of expenditure, all personal matters e.g. recruitment, promotion, amendment of recruitment rules, pension cases, clearance of audit objections/paras etc. He will also function as Drawing & Disbursing Officer.

Note 4: The departmental Administrative Officer in the pay band -2, Rs.9300-34800 plus Grade Pay of Rs.4600 with seven years regular service in the grade will also be considered along with outsiders and in case he or she is selected for appointment to the post the same shall be deemed to have beenfilled by promotion.
