- 1) Under the head 'GENERAL TERMS AND CONDITIONS FOR SUBMISSION OF TENDER FOR OPERATING FOOD CART / CANTEEN AT NATIONAL GALLERY OF MODERN ART, MUMBAI ON LEAVE AND LICENSE BASIS' page No.5, point number 8 (iii), '10%' should be read as '5%'.
- 2) Under the head 'GENERAL TERMS AND CONDITIONS FOR SUBMISSION OF TENDER FOR OPERATING FOOD CART / CANTEEN AT NATIONAL GALLERY OF MODERN ART, MUMBAI ON LEAVE AND LICENSE BASIS' – page No.5, point number 8 (iv)"Pay entire amount of annual license fee in the form of a Bank Draft in favour of 'DDO, NGMA, Mumbai'" be read as "pay the license fee amount six monthly from the date of commencement of business".
- 3) Under the head 'TERMS AND CONDITIONS FOR RENDERING SERVICES FOR RUNNING <u>Food</u> <u>Cart</u> ON LEAVE AND LICENSE BASIS IN NATIONAL GALLERY OF MODERN ART, MUMBAI', on page number 6, point number 3 should be read as

"The Licensee shall pay to the NGMA (M) / Licensor, license fee of Rs.2,22,000 (Rupees two lakhs twenty two thousand only) annually for such use and facilities provided for, more fully described in the Schedule of Agreement. The monthly license fee shall be inclusive of electricity and water charges as well as mandatory taxes. 4) Under the head 'TERMS AND CONDITIONS FOR RENDERING SERVICES FOR RUNNING <u>Food</u> <u>Cart</u> ON LEAVE AND LICENSE BASIS IN NATIONAL GALLERY OF MODERN ART, MUMBAI', on page number 6, point number 3 should be read as

"The License to operate the <u>Food Cart</u> will be valid initially for a period of one year from the date of commencement of contract subject to satisfactory operation and service as per the agreed terms and conditions. The licence may be renewed on year to year basis for a maximum period of <u>three years</u> with a <u>5% increase</u> every year calculated on the License Fee, subject to compliance of the terms and conditions of the agreement by Licensee and providing satisfactory services by the Licensee and at the sole discretion of the Licensor."

5) Under the head 'TERMS AND CONDITIONS FOR RENDERING SERVICES FOR RUNNING <u>Food</u> <u>Cart</u> ON LEAVE AND LICENSE BASIS IN NATIONAL GALLERY OF MODERN ART, MUMBAI', on page number 9, point number 20 should be read as

"The successful tenderer / Licensee shall have to execute an Agreement / Deed of License (proforma for which is enclosed) within <u>seven days</u> from the date of the work order and pay to the Licensor six monthly license fee payable within 7 days of the expiry of the six month period."

- 6) Under the head 'TERMS AND CONDITIONS FOR RENDERING SERVICES FOR RUNNING <u>Food</u> <u>Cart</u> ON LEAVE AND LICENSE BASIS IN NATIONAL GALLERY OF MODERN ART, MUMBAI', on page number 9, point number 21 <u>stands deleted</u>.
- 7) Under the head 'TERMS AND CONDITIONS FOR RENDERING SERVICES FOR RUNNING Food Cart ON LEAVE AND LICENSE BASIS IN NATIONAL GALLERY OF MODERN ART, MUMBAI', on page number 9, point number 23 should be read as

"The Licensee shall have to deposit to the Licensor an additional sum equivalent to 5% of the annual license fee for the entire period of contract as security deposit for the due and complete performance of the provision of the terms, conditions and agreement and for providing satisfactory service in <u>Food Cart</u>. The deposit shall be made by cheque / bank draft in favour of 'DDO, NGMA, Mumbai' payable at Mumbai and no interest will be paid on the deposit for the period the Licensor retains it. The security deposit shall be refunded to the Licensee on successful completion of the period of the leave and license agreement, after deducting cost of damages and/or adjustment of any other dues."

"The Licensee agrees to pay the Licensor a six monthly compensation of Rs.1,11,000 (18,500/- x 6) (Rupees One lakh Eleven Thousand only) by cheque on or before the seventh day after the expiry of six month period from the date of commencement of business."
